A Successful Recruiting Model

If any of you—general members or state and local chapter chairmen—are looking for a way to recruit in your community or in a community nearby, here is one that should work in pretty much any small town. It is modelled after the Tennessee League of the South's annual meeting, which I attended on 14 June.

The meeting was held in the small town of Linden, the county seat of Perry County—the least populous in the State. Linden's population is perhaps 2,000 people. We met in The Commodore Hotel, built in the 1930s, but recently refurbished. It was a fine venue for what turned out to be a very successful meeting.

Tennessee State Chairman David Jones lives in Perry County, and for weeks before the State meeting, he saturated the area with copies of *The Free Magnolia*. He also got a story about the meeting into the local paper. Since small-town newspapers are hungry for news, getting something in them is usually easy. Consequently, several locals attended, and they were positive about the League's message. It was encouraging to see new faces among the old reliable members who showed up.

Our natural constituency lives in small towns all across the South, many of them within a three-hour radius of one or more League Board Members, State or Local Chairmen.

In a two-hour meeting with two League speakers, we can explain in some depth what the League is doing statewide and nationally, with time at the end for questions and comments. Of course, we ought never to miss an opportunity to distribute copies of *The Free Magnolia*. Don't forget to have a sign-up sheet and get names and addresses for your database, and to set up a table with LS books and educational products for those who want still more information. Giving away some free League materials would be a good thing as well, or give away *The Grey Book*, for instance, as a door prize.

About a month before the scheduled meeting, nearby members should saturate the area with copies of *The Free Magnolia*, in which flyers announcing the local meeting have been placed. Those nearby League members should commit to attending the meeting to provide a core group and to get to know potential recruits.

Each attendee should be given a packet of information on the League. It might contain a bumper sticker, a copy of *The Free Magnolia*, a League application,

or other materials explaining our goals and objectives. An informal and friendly atmosphere will impress our prospective new members. Avoid negativity at all costs; anyone can do the old "ain't it awful" routine. We want to be seen as an organization that provides a positive vision for the future of the South.

After the meeting, be sure to send a follow-up letter or e-mail to all who attended, asking them to consider joining the League, if they haven't already.

To encapsulate: 1) Identify the small town where you wish to hold the meeting and set a date at least a month in advance; 2) Locate a suitable meeting place; 3) Get a commitment to speak from two nearby Board Member(s) and/or State or Local Chairman; 3) Decide on the material to be presented by the two speakers. At that point, the groundwork of saturating the county would begin.

Such a series of meetings will be a little work, but shouldn't be an intolerable burden on anyone if we all work together and do a little bit each for the cause. Our natural constituents are those in and near small towns, and they have been hit hard by the bad economy and the war. Many will be eager to listen.

IN MEMORIAM
Mark Royden Winchell, Ph.D.
24 July 1948 - 8 May 2008

Dr Mark Royden Winchell, distinguished scholar, author, and Director of the LS Institute for the Study of Southern Culture and History, lost his two-year battle with cancer May 8th. Professor of Literature and European Civilisation at Clemson University, Dr. Winchell was an exemplar of the Southern literary tradition, although a native of Ohio. He received his PhD at Vanderbilt University during the last days of Agrarian influence there.

His published works are too numerous to list here, but include works on Cleanth Brooks and Donald Davidson (completing a project begun by M.E. Bradford), and a reader for English composition courses coedited with his wife, Donna H. Winchell, a scholar of African-American literature at Clemson.

He leaves his wife, two sons, and a host of friends and admirers.

A TRUE UNDERSTANDING OF THE SECOND AMENDMENT FROM A TENNESSEE LEAGUE MEMBER

Dear Dr. _____:

I am writing in response to your post . . . I wholeheartedly and enthusiastically agree with most everything you are doing at Front Sight. However, I would like to respectfully point out a flaw—potentially fatal—in your logic.

You're absolutely right in stating that "we have a permit that our Founding Fathers gave us. It is called the Second Amendment." You further explain, however, that legislators have indeed passed laws that restrict law-abiding citizens from carrying weapons. You concede that those legislators and the law enforcement personnel who enforce those illegitimate laws are violating their oath to protect and defend the Constitution, yet you then imply that we should submit to such by applying for a permit.

According to the U.S. Supreme Court:

"All laws which are repugnant to the Constitution are null and void."

Marbury vs. Madison 5 US (2 Cranch) 137, 174, 176, (1803)

repugnant: *adjective* — in conflict with, incompatible with.

null: *adjective* — having no legal binding force; invalid.

void: *adjective* — not valid or legally binding.

In other words, *all laws which serve to limit or undermine the right of the people to keep and bear arms are not valid; they have no legally binding force. It is as if they were never written.*

I presently hold a "handgun carry permit" for the State of Tennessee, where I live. When I applied for it, I did not understand that I was trading a *God-given right* for a *state-granted privilege*. I will soon be moving to another State, and I can tell you that I will *not* be applying for another "permit" once I am there. That anyone would have the audacity to tell me how, or when, or where, or even *if* I can defend myself, my family and my property is beyond what I can or will accept.

I'm not trying to be argumentative, but in all seriousness what rationale can you give for submitting to paperwork and registration tyranny now in the name of retaining the means to defend ourselves and perhaps one day repulse a greater form of tyranny? Either we have the God-given right or we don't; either the Constitution guarantees us that right or it doesn't. The fact that ignorant and loathsome legislators and power-mad law enforcement personnel do not recognize or understand this matters not one whit. I will no longer squabble over my God-given rights with petty bureaucrats.

I submit to you that part of the Founders' intent in forbidding any regulation or registration of arms was so that the government would not

know who owned them or how many they had. The fear of the unknown is partially what keeps the tyrants in check.

Sir, I am convinced that the only purposes of a "carry permit" are to levy a tax ("application fee") on yet another right of the People and to have a ready-made list of all gun owners—namely those who actively train and are prepared to use them, as most permit holders are to some degree—so that when the government sees fit to confiscate all arms and/or declare martial law, *they know exactly where to start and with whom*. Once they are taken care of, the remainder of the population can be easily rendered defenseless.

Exciting New Project Needs Funding

A sophisticated automated telephone polling program is being developed for the League by the amazingly talented, Mike Crane (League member and driving force behind the Southern Party of Georgia). The program, which Mike calls “a perpetual recruiting machine,” will allow us to target certain areas of the South with a series of poll questions designed to: 1) determine the level of support for the League’s goals; and 2) capture the contact information of those who give favourable answers to the poll questions. The contact information will be put on a permanent database, and the respondents will be solicited for League membership. Demographic information captured will enable us to aim our marketing efforts at areas where they are likely to be most successful.

Nothing, however, is free—although this system will cost only a fraction of what the national polling services charge and will give us some flexibility where they can’t. It will cost at least \$1,000 per month to run a test program, which we think can be ready by early summer. The League Board is currently developing the poll questions, and the Board and State Chairmen will determine the state(s) in which the test polls run. We expect initially to make around 20,000 calls per month in a particular state; and we estimate that, from this number, approximately 1,000 prospects should result. If only five percent of prospects joined the League at \$50 each, the program would pay for itself and for the next 20,000 calls.

In addition to *The Free Magnolia* which debuted in January 2007, this project is one of the League’s most promising and important to date. Please help us fund it! National Guard Pullout

The thousands of National Guardsmen sent to reinforce the U.S.-Mexican border two years ago have almost completely withdrawn, despite pleas from border-state governors once skeptical of using soldiers to catch illegal immigrants and drug smugglers...

In late April, California Gov. Arnold Schwarzenegger and Arizona Gov. Janet Napolitano joined Richardson in signing a letter to Capitol Hill leaders begging them to extend the National Guard's presence.

"It is irresponsible to phase out the current support of the National Guard without the infrastructure and full-time personnel to fill the gap," the letter said.

This is just one more outrage that would give any time-travelling Founding Father an instant stroke. The very idea that the once-sovereign States must "beg" the Federal government for protection—denied use of what was once their own State militias—would've been inconceivable to Washington, Jefferson, and Madison.

But DC is busy playing international power politics with those troops, so they can't be spared in anything as mundane and un-sexy as protecting Americans from Mexican drug lords and illegal alien invaders.

How much longer until the people of the States recall the delegated powers and treasure DC is squandering? Crises like this will certainly hurry the day.
